- I. Call to Order
 - Vice chairman Johnston called the full-board meeting to order at 8:55 a.m.
- II. Approval of Board Meeting Minutes

Mr. Sonnenberg motioned to approve minutes from the February 12, 2016 board meeting. It was seconded by Ms. Simmons and all members present voted aye.
- III. Board Business
 - The IATSA conference has been scheduled for July 27-29, 2016.
 - ◆ The SOMB may be allotted time on 7/27 for presentation.
- IV. Subcommittee Reports
 - Ms. Iverson reported on the cost benefit analysis that was conducted for the Juvenile Registration Subcommittee.
 - There was no report from the Adult Registration Subcommittee.
- V. Complaint P-2015-01 Review
 - Ted Tollefson, Deputy AG presented a memorandum regarding case number P-2015-01.

Mr. Crawford motioned to authorize closure in case number P-2015-01 with informal discipline. It was seconded by Dr. Johnston and all members present voted aye.

- VI. Old Business
- Mr. Burnham reported on the SOMB updates that were given to the Senate and House Judiciary and Rules Committees. Members of the House committee expressed interest in the tiered registration proposals moving forward.
 - Mr. Burnham also reported on his presentation to the ICJC. They invited him to return to continue discussion about the tiered registration proposals.
- VII. IDOC SOTP Update
- Henry Atencio, IDOC Deputy Director and Ashley Dowell, IDOC Prisons Division Deputy Chief updated the board on the department's plans for sex offender programming for incarcerated offenders.
 - The department will move forward with implementing the University of Cincinnati Sex Offender Curriculum.
 - ◆ It was suggested that they give a presentation at the IATSA conference to inform community providers about the program.
