I. Call to Order

- Chairman Burnham called the full-board meeting to order at 9:10 a.m.

II. Approval of Board Meeting Minutes

Ms. Simmons motioned to approve minutes from the March 18, 2016 board meeting. It was seconded by Sheriff Thomas and all members present voted aye.

III. Board Business

- The IATSA conference has been scheduled for July 27-29, 2016.
 - ◆ The SOMB would be happy to present on a topic to be determined.
- The IJJA is interested in having the SOMB present on the risk-based juvenile registration proposal during its September meeting.
- Training on psychosexual evaluations is needed with implementation of the QA process to address issues.
- Mr. Crawford suggested developing a mandatory training for SOMB-certified post-conviction sex offender polygraph examiners to meet certification renewal requirements.
- Mr. Betts suggested developing a feedback/mentoring process as a service offered by the board for evaluations.

IV. Subcommittee Reports

- Mr. Burnham reported on the Juvenile Registration Subcommittee.

- ◆ The proposal has been modified to eliminate risk “levels” and refer instead to public registrants and non-public registrants, which are still risk-based categories.
- ◆ A suggestion was made to include a defense representative on the subcommittee.
Ms. Simmons motioned to add a defense attorney to the Juvenile Registration Subcommittee. It was seconded by Ms. Fisher and all members present voted aye.
- There was no report from the Adult Registration Subcommittee.

V. Old Business

- Mr. Burnham reported on discussion with the ICJC. They invited him to return to continue discussion about the tiered registration proposals.
