 - ◆ Guidelines, not standards
 - ◆ Submit standards package without this section in either the rules or the quality assurance portion
 - ◆ Community supervision guidelines will follow as a policy statement recommendation
- Administrative Rules
 - ◆ Will be repealed and submitted as temporary/proposed and re-written in whole due to extensive changes
 - ◆ No statutory changes will be proposed at this time

Chairman Evans called for motion to approve the SOMB standards and Administrative Rules as re-written. Ms. Bedal motioned to approve, Ms. Simmons seconded; motion carried unanimously.
