- I. Call to Order
 - Chairman Evans called the full-board meeting to order at 09:10 a.m.
 - II. Approval of board meeting minutes

Sheriff Huff motioned to approve minutes from the January 10, 2014 board meeting with correction. Seconded by Dr. Johnston; motion carried unanimously.
 - III. Old Business
 - Mr. David Prescott has provided an outline for the 24-month cycle of training
 - ◆ Review
 - ◆ Consider audience
 - Non-clinical, judiciary, court staff, probation staff
 - ◆ Victim-specific piece needs to be added yet
 - ◆ Juvenile element will be developed and presented separately
 - ◆ Would like to begin by July 1, 2014
 - Provide feedback to Ms. Baird by Friday February 21, 2014
 - ◆ This is a framework, Mr. Prescott will not develop the entire training
 - IATSA
 - ◆ Meeting next week
 - ◆ Will likely postpone annual conference until Fall 2014
 - Treatment Standards Suggestion
 - ◆ A provider has contacted the SOMB asking if there will be a standardized treatment plan; and

- ◆ Will the SOMB be offering any training on expectations; a workshop for providers and the QA process/procedures
- ◆ Consider a standardized Treatment Consent Form
- Mr. Burnham presented to IJACC outlining where the SOMB is with Juvenile standards and where we are headed

SOMB Certified Sex Offender Treatment Provider

Dr. Johnston motioned to hold the application of Blake Poe, LCPC. He has substantially met the requirements of qualification for Senior level Treatment Provider certification but we have not received all of the required treatment materials. Mr. Betts seconded the motion. All members present voted aye.

SOMB Certified Treatment Provider and SOMB Certified Psychosexual Evaluator
Mr. Evans motioned for conditional approval of Senior level Treatment Provider certification application pending receipt of information on old treatment procedures for Dalton Lombard, D.Min, LCPC. Mr. Burnham seconded the motion. All members present voted aye.

Mr. Burnham motioned to approve the Senior level Psychosexual Evaluator certification application for Dalton Lombard, D.Min, LCPC. Sheriff Huff seconded the motion. All members present voted aye.

Mr. Betts motioned to approve the Senior level Psychosexual Evaluator certification application for Chad Sombke, Ph.D. Dr. Johnston seconded the motion. All members present voted aye.
