- I. Call to Order
 - Vice Chair Johnston called the full-board meeting to order at 8:35 a.m.

 - ♦ Work has been suspended pending STATIC-99 coding rule modifications and work on consistency in psychosexual evaluations.

 - ◆ Pending planning to develop a 2-level system; a mechanism is needed for movement between levels; and work on consistency in psychosexual evaluations. A process for review of inadequate psychosexual evaluations needs to be developed.
