- Executive Session Certification Subcommittee
 Dr. Johnston motioned to enter executive session, citing I.C. 67-2345(1)(d) at 08:10
 a.m. Seconded by Ms. Bedal; motion carried unanimously.
- II. Regular session
 Ms. Garay motioned to return to regular session at 08:47 a.m. Seconded by Ms.
 Bedal; motion carried unanimously.
- III. Call to Order
 ➢ Chairman Evans called the meeting to order at 08:48 a.m.
- IV. Approval of Board meeting minutes
 Mr. Burnham motioned to approve minutes from the June 8, 2012 Board meeting.
 Seconded by Sheriff Huff; motion carried unanimously.

- V. Old Business
 - Chair Evans presented that the Felony Sentencing Committee has indicated they would like to see a mandated cost set by the SOMB for Psychosexual Evaluations.
 - Recommend sending surveys, with a breakdown of the costs for the mandatory tests required with the new evaluation format, requesting impact to each group:
 - Dan Chadwick, Idaho Association of Counties

- Juvenile Probation Offices
- Adult Probation Offices
- Idaho Prosecuting Attorneys Association
- Idaho Association of Criminal Defense Lawyers
- Explore the option of doing web-interviews to reduce costs of evaluations
- VI. Tiered Subcommittee Presentation
 - > Dr. Johnston, Tiered Subcommittee Chair, presented:
 - Registration for Adult Sexual Offenders in a matrix system
 - Categories of severity based on crime
 - An initial tier level designation will be assigned
 - Within 120 days of initial category assignment (post-conviction) Dynamic, Static and Protective risk factors will be evaluated and final tier level will be determined
 - Subcommittee will review and make recommendations to full board
 - ◆ Tier Level Reductions:
 - Offenders requesting Tier Level Reductions will be responsible for providing their own Psychosexual evaluation
 - Reviewed by Tiered Subcommittee and then presented to full board for decision, or;
 - Reviewed by Tiered Subcommittee and SOMB then recommendation presented to Court for review and determination of level.
 - > Subcommittee will be looking at juvenile requirements separately.
 - More due diligence; based on national research
 - Registration and reporting requirements for juveniles will be heavily scrutinized
- VII. Review Evaluator Comments
 - > No additional feedback from evaluators who received the draft guidelines for review.
 - All comments, suggestions, and recommendations will be compiled into one document that will be posted to the SOMB website prior to public meetings.
 - Consider having public meetings outside of Treasure Valley to maximize participation.
- VIII. Draft Guidelines Review
 - Categories of SOMB-Certified Psychosexual Evaluators
 - Include language in Senior Evaluator standards encouraging their acceptance of Associate Level evaluators
 - At least one (1) report per year
 - Must verify that associate work is reviewed
 - Populations in rural areas
 - SOMB reserves the right to make exceptions
 - Administrative Policies
 - ◆ Reviewed latest draft from Ms. Baird
 - Will move forward to final draft
 - Treatment and Treatment Provider Standards
 - Review and Discussion
 - Certification for Individual and Program
 - Quality control over programs
 - Include stronger language requiring reports to the Courts and to Probation and Parole

- Changes and recommendations will be incorporated
 - Request that members with treatment-specific knowledge provide language for program certification that will become Section IV.

Mr. Betts motioned to provisionally renew psychosexual evaluator certification for Chad Sombke, Ph.D. Seconded by Mr. Burnham; motion carried unanimously.

Mr. Betts motioned to provisionally renew psychosexual evaluator certification for Stephen Lindsley, LCPC. Seconded by Ms. Bedal; motion carried unanimously.

Mr. Betts motioned to provisionally renew psychosexual evaluator certification for Dalton Lombard, D.Min. Seconded by Ms. Bedal; motion carried unanimously.
