I. Call to Order

- Follow up on publication of an average cost of a Psychosexual Evaluation when these new standards are enacted
 - Chairman Evans and Ms. Baird will work together to make something available for the counties and the public
- Received a telephone call from a provider with questions
 - ♦ If a provider receives a Master's Degree in another state and that program requires fewer hours than Idaho, are they then qualified
 - Verify licensure check reciprocity
 - If the supervisor is not currently practicing treatment, is that going to be an issue
 - Will have to apply to be a Senior-level provider
 - We want people who have that experience who are willing to supervise
 - Demonstrate flexibility
 - Expect that scenario to be more common

- V. Proposed Guidelines Review Community Supervision
 - Welcome Jeremy Clark, IDOC Clinical Supervisor
 - Working with IDOC Probation and Parole developing standards for sex offender supervision and continuity of care from Intake through community supervision
 - Moving everyone to risk-based supervision philosophy
 - Supervision level based on Static 99R upon release from custody
 - ♦ After 1 year, reassess and use Stable
 - Female offenders: appropriate to use Stable, even while incarcerated
 Will help to place them into the matrix
 - Alleviates some of the current rigidity of supervision and allows for an offender that is making improvements to have supervision level reduced
 - Managing vs. punishing approach
 - Allows the focus to be directed to those that need it most
 - Questions about introductory paragraph
 - ♦ Ms. Baird will review current legislation to rework language
